The Versagel HSQ provides excellent suspension of fine glitter particles and dries to a smooth velvet finish. The formula is easy to apply, leaving skin with a moisturized radiant glow.

Procedure:

1. Add the ingredients of phase A sequentially, mixing until completely homogenous after each addition.
2. Disperse the pigments into the Caprylic/Capric Triglyceride to obtain a slurry.
3. Add phase B to phase A and mix until completely dispersed.
